- *Involvement in local & county service – 25 points*

2011 Business Improvement of the Year

- *Measureable improvement to a building, interior or exterior or expansion of existing facility – 50 points*
- *Outstanding economic impact – 50 points*

2011 Covered Bridge Festival Volunteer Award

- *Excellence in performance – 30 points*
- *Outstanding leadership overseeing volunteers – 30 points*
- *Years of dedicated service – 30 points*
- *Involvement in other local & county service projects – 10 points*

2011 Customer Service of the Year Award

- *Measureable and effective customer service – 30 points*
- *Impressive customer numbers – 30 points*
- *Involvement in local & county service*

2011 Chamber Volunteer of the Year

- *Outstanding volunteer service to the Chamber – 30 points*
- *Quality leadership of a program or project – 30 points*
- *Involvement in local & county service projects – 30 points*
- *Other unique qualities – 10 points*

2011 Lifetime Achievement Award

- *Outstanding contributions to community – 25 points*
- *Dedicated, quality leadership of a business or organization – 25 points*
