 - Pop up tents for shade at each location (they will not be moved to accommodate artist)
 - Lunch and dinner
 - Water and non-alcoholic beverages throughout the day of the event
- Artists can promote their artwork during the festival and can promote tips via electronic and/or cash collections.
- No smoking/vaping within any locations.
- Artists are expected to finish at least one piece of artwork during the event to auction off at the reception.
- Artists are expected to bring their own materials.
